From the Executive Director

ADVOCACY WORKS!

In the days before the final votes were cast on the Federal Economic Recovery Package 80,000 people contacted congressional offices asking that the \$50 million for the National Endowment for the Arts be included. They also asked to defeat the Coburn Amendment, which excluded museums, cultural and community centers from receiving stimulus funds. This was truly a cliff-hanging moment. And the advocacy worked! While we won't know just how these funds will be distributed until late April, the NEA knows that the process needs to be speedy and efficient.

We are tracking a variety of components of the overall stimulus package which might provide arts funding as well, such as Community Development Block Grants to support economic development projects, Title I funds for schools which can be used for arts education, capital improvement projects to which we can apply Percent for Art, and transportation enhancement efforts, among others.

At the local level RACC is in full advocacy swing for next year's budget requests to the City, three Counties and Metro and we need you! This is clearly a tough year for all funding and we need a strong and significant army of advocates to at least hold public arts funding at this year's levels. Please – when we contact you with an action alert – heed the call! Everyone can make a difference as we learned in Washington DC. Thanks.

New Strategies Emerge from New Economic Realities

In this economic downturn it can be hard to escape from the constant barrage of bad news. Budget shortcuts, layoffs, general misery all around. But we at the Regional Arts & Culture Council have observed a lot of smart thinking across the arts community these past several months, and we applaud the many ways in which artists and arts organizations have proven themselves nimble in making necessary adjustments during these difficult times.

As the financial challenges continue – and none of us know when things will improve – RACC has a reminder for the arts community: we are here to help, and we too have a revised plan for making sure that arts and culture continue to thrive.

In the months ahead, RACC will achieve modest savings on some of our administrative expenses while bolstering our most effective programs to serve the arts community better than ever before. If we can secure the funding we've requested from each of our government partners, with only minor cuts, our goal will be to hold arts organizations harmless, while continuing to focus on programs that leverage new dollars for the arts community. We want to continue to be the place you come to communicate, convene and collaborate, and we want to be a stronger advocate for you—helping prove to our neighbors and elected officials that the arts are truly vital.

These goals have been gleaned from a series of conversations RACC hosted this fall and winter with arts leaders, foundations, and our own staff and board, where we asked the question: how can we put all of our services to the best use during the current economic crisis? As a foundation for these discussions, RACC's Cultural Leadership Program consultant and co-director of Arts Action Research, George Thorn developed a six-point strategy for all arts organizations affected by the crisis.

Thorn's recommendations (available online at www.racc.org/toolkit) encompass a new, streamlined reality to deal with the economic uncertainty surrounding us. They describe the need for organizations to clearly articulate their mission and programs, explaining what they do, why they do it and how they add value. We must all maintain and deepen current relationships while also developing new ones. We should adjust our expectations for every budget revenue line item, both earned and contributed, while making prudent budget cuts to close the gap. We should approach

those with whom we have relationships to ask them to match our work. All distractions should be eliminated, including those from individuals who bring negative, unconstructive energy.

With Thorn's strategic plan in mind, RACC has expanded and modified some of our previously established goals to better respond to the times. Specifically, RACC will:

Enhance effective programs

- Broaden Work for Art outreach to secure workplace giving campaigns at more corporations and small businesses.
- Maintain arts education efforts through The Right Brain Initiative, expanding to new schools where funding makes this possible.
- Re-direct some funds from under-utilized programs to help fund more Professional Development programs.
- Find funding to continue the Cultural Leadership Program in 2009 and 2010.
- Be poised to help implement arts-related projects that may be funded through the Portland region's share of the Economic Recovery Package.

Communicate and convene

- Lead the arts community in strengthening and aligning arts advocacy messages.
- Coordinate strategies among stakeholders in the arts, working to ensure that similar initiatives are aware of each other's efforts, and helping reduce duplication where possible.
- Provide useful information to the arts community through an online toolkit (www.racc.org/toolkit).
- Help convene audience-building initiatives and collaborative cross-promotion efforts.

Strengthen advocacy efforts

- Support the Creative Advocacy Network, our key to a long-term dedicated funding solution
- Advocate for continued arts funding from foundations.
- Organize effective advocacy around RACC's funding requests for the next fiscal year, especially around the \$3.9 million arts request to the City of Portland. Recruit advocates from all sectors of the community, including social services, to assist with lobbying efforts.
- Motivate more civic leaders to lead and communicate by example, such as by writing op-eds.
- Help obtain increased revenues and/or reduced expenses for arts organizations. (For example, RACC will appeal rate hikes that impact the arts community, and seek common savings solutions for housing, hotels, and health insurance.)

Though the news around us may be bleak, artists and arts organizations are demonstrating tremendous poise and resiliency. RACC supports you all in these efforts, and we are ready to be of service.

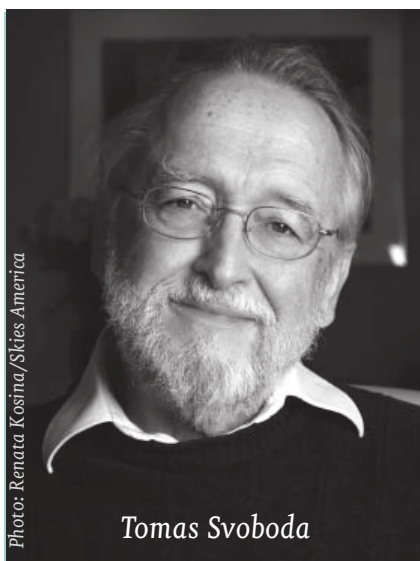
